## Feedback Analysis and Action Taken Report

(AY.2019-2020)

Date- 27/5/2020

The academic year 2019-2020 witnessed the unique challenge to the conventional education system. Due to lockdown induced by the pandemic caused due to Covid 19, the college had to switch to online teaching tools at the end of the second semester. In this year many new activities and initiatives such as CARPEL, international conference, Faculty development programs, publication of research journal for students were introduced and conducted successfully by the college. For evaluating the performance of the college, following feedback processes were used:

- 1. Faculty Feedback: -. Every year feedback of faculty members is taken from students in the structured format. Criteria wise evaluation of teacher such as use of ICT tools, ability to communicate the contents, ability to maintain the interests of students is done through this feedback.
- 2. Employer Feedback/Internship Provider Feedback: Feedback from advocates and law firms providing internships to our students is collected by the Placement Cell andanalysed.
- 3. Parent Feedback: Parents feedback about their experience with the college and their opinion about the curriculum is taken and analysed. Parent teacher meeting was also arranged to ascertain the feedback and suggestions from the parents.
- 4. Event Feedback from participants: Feedback about various events organized by the college is taken from the participants. These various feedbacks collected at the end of the events were analyzed and discussed in detail.
- 5. Student Satisfaction Survey: -For the purpose of understanding the student satisfaction regarding the overall performance of the college, the student satisfaction survey was conducted by using Google form. The questions of the survey are attached herewith. As many as 383 students from various classes have given their response. Their feedback is analyzed and discussed in detail.

Observations: -All these feedback processes led to following observations-

- 1. Average feedback of faculties is found to be more than 60%, which is satisfactory.
- 2. Parents as well as students feedback exhibited the suggestion for providing training for specialized branches of law.
- 3. Feedback from the participants of various events is good. Participants have found the overall management of programs by the institution to be satisfactory.
- 4. The feedback of certificate courses conducted by the 'Centre for Advanced Legal Research and Training' regarding the content, quality of resource person and number of sessions is good. Some students have given suggestion for conducting the courses continuously.
- 5. Following are the pertinent observations as to Student Satisfaction Survey-
- a. As many as 60.3% of the students feel that the curriculum drafted by the Savitribai Phule Pune University provides the opportunity to develop the skills required for the profession but at the same time 79.1% of students expressed the need to modify the syllabus to adapt itself with changes in the modern society such as cyber-crime etc.
- b. The overall feedback regarding the satisfaction of students as to the various aspects such as teaching learning environment, overall administration, exposure to curricular and co-curricular activities etc ranges from good to excellent. This is really very satisfactory. Students are quite satisfied about the co-operation and support from the staff. There are however some important suggestions such as need to have student exchange programme, arranging more lectures and guidance session for the students aspiring to join judiciary.

## **Action Taken Report**

Action Taken: - 1. At the time of conclusion of the academic year 2019-2020 the feedback received from different stakeholders was discussed in the staff meeting held by the Principal.

2. The faculty feedback was communicated to each faculty in person. For updating the faculty about the use of technology in teaching, faculty members were given support for attending various faculty development programmes.

- 3. Regarding the feedback about conducting the certificate courses by the centre in a continuous manner, it was decided that in the next academic year some of the courses will be conducted continuously in one stretch.
- 4. Regarding the suggestion about the student exchange programme, concerned faculty in charge is already working on it and such program collaboration with the Colombo University is already in the process of approval.
