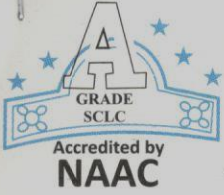

Feedback Analysis and Action Taken Report

(AY.2020-2021)

Date-28th June, 2021

The academic year 2020-2021, as the first wave of the covid-19 was over; physical classes were resumed and as per the guidelines of the local government and Savitribai Phule Pune University, hybrid classes (offline and Online Mode) were conducted. However all the events and programs were conducted through online mode. Taking in consideration these changes, feedback processes for evaluating the performance of the institution were modified and implimentated.

For evaluating the performance of the college, following feedback processes were used: -

- **Faculty Feedback:** -. Every year feedback of faculty members is taken from students in the structured format. This year each class teacher collected the online feedback of the subject teacher. Criteria wise evaluation of teacher such as use of ICT tools, ability to communicate the contents, ability to maintain the interests of students is done through this feedback.
- **Student Satisfaction Survey:** -For the purpose of understanding the student satisfaction regarding the overall performance of the college, the student satisfaction survey was conducted by using Google form. The questions of the survey are attached herewith. As many as 179 students from various classes have given their response. Their feedback is analysed and discussed in detail.
- **Parent Feedback:** - Parents feedback about their experience with the college and their opinion about the curriculum is taken and analyzed. Parent teacher meeting was also arranged to ascertain the feedback and suggestions from the parents.
- **Employer Feedback/Internship Provider Feedback:** - Due to Covid 19, majority of the internships provided by the placement cell were in online format. Online Feedback from advocates and law firms providing internships to our students is collected by the Placement Cell and analysed.
- **Event Feedback from participants:** - Feedback about various events organized by the college is taken from the participants. These various feedbacks collected at the end of the events were analysed and discussed in detail.

Observations: -All these feedback processes led to following observations-

1. Average feedback of faculties is found to be more than 60%, which is satisfactory.
2. The feedback received by the Placement Cell contained the suggestion as to need to improve soft skills and ability to handle e-resources.
3. Feedback from the participants of various events is good. Participants have found the overall management of programs by the institution to be satisfactory. Regarding feedback of international conference contained the suggestion for curtailing the number of sessions per day. Participants have noted that to retain the attention and concentration, number of session in a day should not exceed three.
4. The feedback of certificate courses conducted by the 'Centre for Advanced Legal Research and Training' regarding the content, quality of resource person and number of sessions is good. Previous academic year there were suggestions regarding continuous conducting of the courses. Accordingly this academic year all certificate courses of the centre were conducted in one stretch.
5. Following are the pertinent observations as to Student Satisfaction Survey-
 - a. As many as 79.9% of the students feel that the curriculum drafted by the Savitribai Phule Pune University provides the opportunity to develop the skills required for the profession but at the same time 81% of students expressed the need to modify the syllabus to adapt itself with changes in the modern society such as cyber-crime etc.
 - b. The overall feedback regarding the satisfaction of students as to the various aspects such as teaching learning environment, overall administration, exposure to curricular and co-curricular activities etc ranges from good to excellent. This is really very satisfactory. Students are quite satisfied about the co-operation and support from the staff.
 - c. There are few suggestions regarding the library such as need to upgrade the library with the study material of new courses.

Action Taken Report

- Action Taken: - 1. At the time of conclusion of the academic year 2020-2021 the feedback received from different stakeholders was discussed in the staff meeting held by the Principal.
