Code of Conduct for Students

- 1. The College believes in promoting a safe and congenial environment, which it does so by enforcing behavioural standards. All students must uphold academic integrity, respect everyone around, their rights, belongings and safety of others, etc.
- 2. A student is expected to maintain 75% attendance per semester. In case a student falls short of attendance, disciplinary action is initiated against such a student.
- 3. Students must note that official works like; examination form, issue of marks statement, revaluation work, etc. all are done through the guidelines of SPPU. Students should strictly follow the schedule given by the University communicated by the College from time to time. College authorities are not responsible in case students fail to do any of such work in the given time schedule.
- 4. Use of mobile phones is strictly prohibited during classroom sessions. In case, any student is found using a mobile phone in the teaching session, his/her mobile phone is confiscated immediately and the student has to face disciplinary action.
- 5. The College uniform is compulsory for all the students. They are required to be in College uniform as prescribed by the Disciplinary Committee of the College. Directions regarding College uniform are given by the Chairman of Disciplinary Committee and concerned class teachers from time to time.

Statutory Committees

Anti-Ragging Committee

An Anti-Ragging Committee and Anti-Ragging Squad is constituted in the College as per the Maharashtra Prohibition of Ragging Act, 1999 and UGC Regulation on Curbing the Menace of Ragging in Higher Education Institutions, 2009.

Ragging is Strictly Prohibited on the College premises. It takes all necessary precautions to prevent the act of ragging. A strict disciplinary action is initiated if any student is found guilty by the act of ragging.

Definition: 'Ragging' means display of disorderly conduct, doing of any act which causes or is likely to cause physical psychological harm or raise apprehension or fear or shame or embarrassment to a student in any educational institution and includes (i) teasing, abusing, threatening or playing practical jokes on, or causing hurt to, such student; or (ii) asking a student to do any act or perform something which such student will not, in the ordinary course, willingly, do.

Penalty for ragging:

Whoever directly or indirectly commits, participates in, abets or propagates ragging within or outside any educational institution shall, on conviction, be punished with imprisonment for a term which may extend to two years and shall also be liable to a fine which may extend to ten thousand rupees.

This unique interactive initiative aimed at bringing students from all around the world on a single platform and address legal issues in the contemporary interconnected world, where SCLC got the opportunity to represent Savitribai Phule Pune University, Pune.

During the visits, Dr. Kranti Deshmukh and Dr. Revati Naik delivered sessions, while students gave presentations and participated in various activities. It was an enriching opportunity to interact with international experts, which paved ways for future collaborations. It enabled the students to get a holistic view of the world, break the barriers of language, culture, and religion so as to assimilate globally.









Academic Expansion through International Faculty-Student Exchange Programmes and Industry-Academia Visits

An International Student-Faculty Exchange Programme with the University of Colombo, Sri Lanka was done, wherein 8 Students and 4 faculty members participated. Students attended various lectures and made presentations before various statutory bodies like the Sri Lanka Human Rights Commission. Faculty members taught a few papers and organised workshops. Academic visits to the Supreme Court of Sri Lanka, High Court of Sri Lanka, Centre for Study of Human Rights (CSHR), Libraries, Bar Council of Sri Lanka, Commercial High Court, etc. were made to understand their legal system. Students got opportunities to interact with the Chairperson of Sri Lanka Human Rights Commission, Judges of various Courts, Bar Council members, and renowned academicians. A Legal Aid Camp at a village named Wanathawilluwa (District: Puttalam) was organised and students visited various UNESCO heritage sites. The Government of Sri Lanka, through respective ministries, positively supported our team which made the visit successful. 





One Day International Webinar on 'Conversance of Consumer Protection Act, 2019 in Different Sectors'







Their works have resulted in reduction of infant mortality rate from 200 per 1000 to 40 and preschool mortality rate from 400 per 1000 to 100.

The Centre for Public Health Laws (CPHL) was established in the year 2021 to create awareness about the Public Health Law and extend legal assistance to the needy.


Following activities have been conducted by the Centre in the AY 2022-23:



This Centre was established by Marathwada Mitra Mandal in collaboration with Tata Technologies Ltd. and Science and Technology Park. The MCIII project investment is about INR 200 million excluding space and infrastructure. It intends to act as a one-stop-shop to provide high end and industry-specific training to convert innovative ideas into products and become entrepreneurs, and provide domain-specific placement opportunities. Through its various departments, the Centre provides training and mentorship to the students, faculties, industry persons, and innovators to upgrade their skills with high-end technology tools and industrial experiential learning. The Centre intends to extend a helping hand to the law firms and law practitioners.



Centre for Alternative Dispute Resolution Systems

The Centre for Alternative Dispute Resolution System was established to provide support and resolve disputes amicably with the maximum satisfaction of the disputants. It is dedicated to promote access to justice and provide a platform for resolving disputes through alternative means. It also organises field visits, guest lectures, and other activities to make students understand the role of ADR.

Active participation of students in Lok-Adalat at Pune District Court, Pune

The Cell organised a One-Day State Level seminar on *Empowering & Educating Youth for the Prevention of Sexual Harassment* on 11th Feb., 2023.



With this objective, the IPR Cell was established at SCLC to provide a platform, share, and discuss latest development and applications with practical exposure to students, faculty members and research scholars.


Following activities were conducted by the Cell in the AY 2022-23:






Film Society






















Late Justice P. B. Sawant 9th National Moot Court Competition

Moot Court Association

With the objective to develop the culture of mooting, SCLC established the Moot Court Association (MCA) in the AY 2015-16. The role of the Association is to facilitate mooting skills of students, which it does so by organising moot court competitions and guest lecturers.

Following are the objectives of the Association:

- 1) To promote mooting skills among the students.
- 2) To ensure better opportunities for competent students in the areas of mooting and other allied activities.
- 3) To raise the competitive spirit of students.
- 4) To encourage and provide a platform for students.
- **5)** To attain academic excellence.

Working of the Association:

1. At College level:

It conducts activities, like; expert lectures, guidance sessions, library visits, intracollegiate competitions, like; moot court, client counselling, etc. which enables optimum use of the resources for research. Demonstrations by service providers are also arranged.

2. Representation of the College:

It acts as a guide and selecting body for the students who wish to represent the College at State, National, and International-level moot court competitions conducted by various organisations. To achieve this objective, the Association conducts intra-collegiate moot court competitions. wherein students participating in the competitions are considered eligible for representing the College in the competitions organised by other institutions. The invitation of any competition received by the College is displayed on the Notice Board. Accordingly, interested and eligible students are asked to present, all of which is supervised by the faculty in-charge. On the basis of presentation skills, depth of knowledge, and conceptual clarity, selection is done and a team is formed. All the necessary financial assistance for student participation is provided by the College.

Activities conducted:

- 1. The Association conducted a Mooting Skill Development Workshop from 13th to 17th September, 2022. Experts were invited to deliver lectures on various topics of relevance. As many as 84 students attended the workshop.
- 2. An Intra-Collegiate Moot Court Competition was conducted from 1st to 3rd October, 2022. It was conducted in two rounds, i.e. Preliminary and Final. 63 students participated in the Competition. Ms. Gargi Chaudhari was declared as the winner. Mr. Harshwardhan Pawar bagged the first runner-up prize, while second runner-up prize was given to Mr. Ashish Patil and Mr. Yash Atre. Mr. Harshwardhan Pawar won the Best Advocate prize, and also the Best Memorial prize.
- 3. In the AY 2023, students from the Moot Court Association participated in 36 moot court competitions, displaying their commitment and dedication towards honing their advocacy skills. This significant number of participation signifies the enthusiasm and passion students have towards engaging in the practical aspect of legal education.


Extending helping hands
