To carry forward the legacy of our Founder President, Late Shri Shankarrao Chavan, a Family Counseling Centre (FCC) was established in the year 2013. It was formally inaugurated on 10th August, 2013 by Hon'ble Justice Anilkumar Dave, Judge, Supreme Court of India in the gracious presence of Justice Sadhana Jadhav, judge, High Court of Bombay, and Justice Vidyasagar Kanade, Judge, High Court of Bombay.

The Centre is working under the able guidance of its President, Hon'ble Justice V. V. Shahapurkar, Former Judge, Family Court, Pune, and counselors Dr. Pravin Motiwala and Mr. Sudam Gayke. It comprises a panel of experts, renowned psychologists, medical practitioners, and legal professionals. It provides counseling to needy people out of gratuitousness. Family Counseling Centre is a recognized mediation centre of Bombay High Court.

This year centre has taken initiative to expand its horizons and approached to the Maharashtra State Commission for Women for recognition and requested them to refer the cases of counseling. In the month of April 2023, Maharashtra State Commission for Women has given recognition to the Family Counseling Centre as Official Counseling Centre. Centre considers it is an achievement. Throughout the academic year, the Centre conducts various activities such as awareness programmes, workshops to sensitize students about gender equality.




