The Family Counseling Centre was formally inaugurated on 10th August 2013, at the auspicious hands of Hon'ble Justice Anilkumar Dave, judge, Supreme Court of India, in the gracious presence of Justice Sadhana Jadhav, judge, High Court of Bombay & Justice Vidyasagar Kanade, Judge of High Court of Bombay.

Therefore, the matrimonial laws in India, including laws on marriage, divorce and other connected issues, are essentially governed by the personal laws of the parties depending on their religion. This is the unique situation where society is facing different problems such as dowry death, honour killing, same sex relationship, increasing rate of divorce, live in relationship etc. There is urgent need to analyze the present laws which will determine its effectiveness in consideration with the present challenges.
