## Feedback Analysis and Action Taken Report

(AY.2022-2023)

Date- 25<sup>th</sup>May, 2023

In the academic year 2022-2023, multiple initiatives were taken by the college for the holistic development of students. Various seminars, workshops, international and national conferences, symposiums and guest lectures on various issues of relevance were organized. To enable students to have experiential learning various visits such as visits to family and district courts, jail visits and visit to police station were organized.

Further to make the professional expertise available for students, the co-teaching policy was adopted specifically for the procedural laws. The co teacher and core teacher taught the subjects which helped the students to understand theoretical and practical perspective of the subject.

To understand and evaluate the performance of the college with respect to teaching learning various activities, events and activities conducted by the college. To achieve this feedback process of the institution was designed accordingly. For evaluating the performance of the college, following feedback processes were used: -

- **Faculty Feedback:** -. Following the tradition, the feedback of the subject teacher was taken by the Academic coordinator. Criteria wise evaluation of teacher such as use of ICT tools, ability to communicate the contents, ability to maintain the interests of students is done through this feedback. After processing it, it was communicated to each teacher. In case of need the corrective measures were also taken. The feedback percentage of each faculty in tabular form is attached herewith as an Annexure I.
- **Teacher's Feedback:** - Teacher's feedback about the curriculum is taken. It is regarding various aspects so as to ascertain whether there is any need to amend or modify the curriculum so as to make it suitable to modern times. The findings of it were



communicated to the university through the medium of teachers of the institute working in Board of Studies of the Savitribai Phule Pune University. The specimen feedback is attached herewith as Annexure II.


- **Student Satisfaction Survey:** - Student satisfaction survey to understand the satisfaction level of students with respect to various facilities provided to them is conducted. As many as students responded to the survey and overall survey is found to be satisfactory. It is conducted online through google form. It is analysed and communicated to the concerned and the corrective action is taken where ever necessary. The questions graphical presentation of the summary of questions and responses given is attached herewith as Annexure III.
- **Parent Feedback:** - For the effective working of the institution, active involvement of parents is utmost necessary. With this objective every year parent teacher meeting is arranged. Parents feedback about their experience with the college is taken and analyzed. The specimen of the feedback report is attached herewith as Annexure IV
- **Employer Feedback/Internship Provider Feedback:** - The placement department of the college collected the feedback of the internship and placement providers. The overall feedback is found to be satisfactory. It is attached herewith as Annexure V
- **Event Feedback from participants:** - Feedback about various events organized by the college is taken from the participants. These various feedbacks collected at the end of the events were analyzed and discussed in detail. The specimen feedback is attached as Annexure VI

**Observations:** -All these feedback processes led to following observations-

1. Average feedback of faculties is found to be more than 70%, which is satisfactory.
2. In the student Satisfaction survey students expressed the satisfaction as to the overall performance of the college with respect to various parameters and it is found to be satisfactory.
3. Feedback from the participants of various events is good. Participants have found the overall management of programs by the institution to be satisfactory.
4. The feedback of certificate courses conducted by the 'Centre for Advanced Legal Research and Training' regarding the content, quality of resource person and number of sessions is good.
5. Following are the pertinent observations as to Student Satisfaction Survey-
  - a. As many as 55.9% of the students feel that the curriculum drafted by the Savitribai Phule Pune University provides the opportunity to develop the skills required for the profession but at the same time 81 % of students expressed the need to modify the syllabus to adapt itself with changes in the modern society such as cyber-crime etc.



b. The overall feedback regarding the satisfaction of students as to the various aspects such as teaching learning environment, overall administration, exposure to curricular and co-curricular activities etc ranges from good to excellent. Overall satisfaction is expressed with respect to teaching and administrative staff. However, there are few suggestions with respect to the library specifically the library timings. Few students have given suggestion for extending the library timings and overall supervision of reading room.
