Student Satisfaction Survey Analysis Report

Academic Year 2021-2022

30th June, 2022

For the academic year 2021-2022, the Student Satisfaction Survey was conducted. The google form of the questionnaire was circulated among students in the last week of May 2022. The link of the same was shared to all students through WhatsApp Group. The survey comprised of four parts. First part was about the curriculum for various programmes, second was about the performance and sufficiency of facilities provided by the library, third was about the administration and last part was for assessing the overall performance of the college with respect to various parameters. As many as 83 students from various programmes responded to the survey.. Following is the pointwise analysis of this survey.

1. **About curriculum:** - In an attempt to ascertain the sufficiency of the curriculum, students were asked the question as to whether they think that the curriculum drafted by the university is apt to get the depth of understanding of the course. 63 out of 83 i.e. 75.9% students have responded affirmatively by opting yes as the answer. While responding to the question that whether the curriculum provides the opportunity to develop the skills required for profession. In response to this question it is found that as many as 79.5% i.e. 66 out of 83 feels that the curriculum provides the inducement for the skill development required in the legal profession. However, 85.5% of the respondents feel that present syllabus needs to be modified taking in consideration the challenges faced by the modern society.

2. **Feedback about Library:** - Overall feedback as to the availability of resources and e-resources found to be ranging from excellent to good. Students feel that the initiatives taken by the institution to extend the library facility to students during pandemic such as remote access to e-library are satisfactory. 31.3% students have found the initiatives to be excellent and 45.8% have found the initiatives to be good. However there are two prominent suggestions with respect library first regarding the library timings and reading room arrangement. Few students have given the suggestion regarding the need to extend the timings of library.
3. **Feedback about Administration and Administrative Staff:** - On the scale of 0-5, 37.3% of students have rated the performance of administrative staff with respect to various processes such as admission, examination as 5 and 29% of students have rated scale of 4. Not a single student has rated the performance on the scale of 1. 91.6% students feel that their issues regarding administration were resolved within stipulated or reasonable time. 96.4% of students feel that the administrative staff is cooperative and helpful. Overall feedback about administration and administrative staff seems to be satisfactory.
4. **Feedback about the overall performance of the Shankarrao Chavan Law College:**
- The feedback of the institution with respect to various parameters is taken on the scale ranging from nan satisfactory to excellent. The parameters are teaching learning environment, academic quality, experience with admission procedure, overall administration, exposure to curricular, co-curricular and extra-curricular activities, courses offered by the college, overall discipline, initiative taken by the college to deal with the challenges posed by pandemic such as online teaching. The response with reference to each of the parameter is observed to range from good to excellent.




Action Taken Report

Library should open by 8:00am.

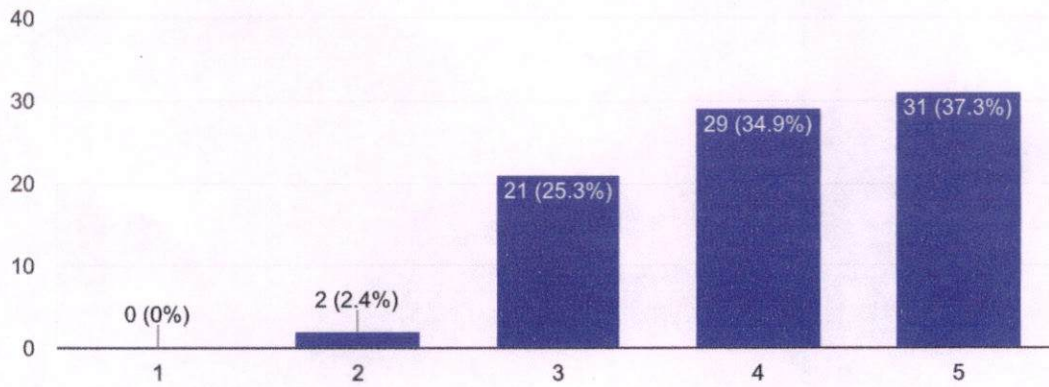

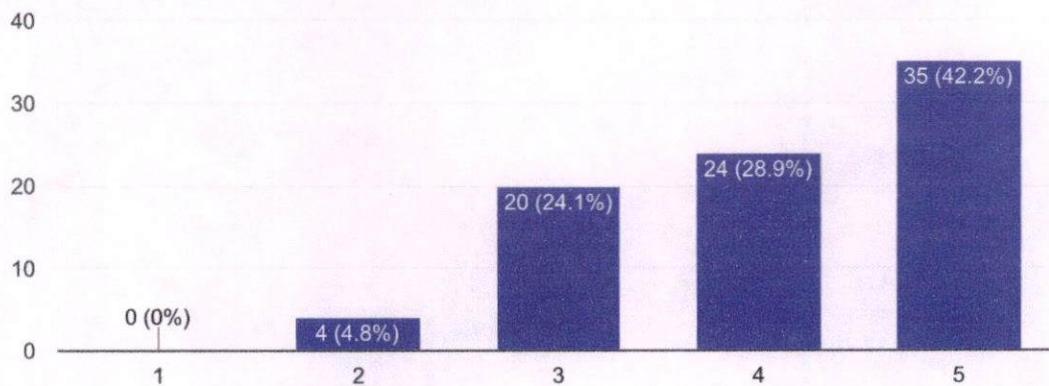

2. How would you rate the response from the office regarding resolution of your difficulties?



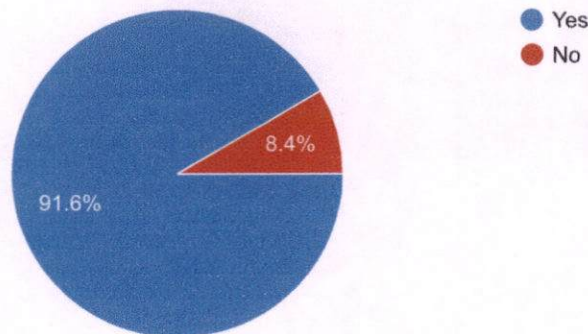
