The Family Counselling Centre, a noble initiative of Shankarrao Chavan Law College stands as a testament to the institution's commitment to societal well-being. Recognizing the increasing challenges faced by modern families, the Centre aims to provide a safe and supportive space for individuals and families seeking guidance, counselling and legal assistance.

Led by the esteemed Hon'ble Mr. V.V. Shahapurkar, Former Principal Judge Family Court, Pune, and Founder President of FCC, the Centre has been a cornerstone of support for those facing marital discord, parental conflicts, child custody disputes, and other family-related issues.

The Centre's multidisciplinary team, composed of legal experts, medical professionals, and experienced counsellors, works collaboratively to provide comprehensive and tailored solutions. Through a blend of counselling sessions, mediation services, and legal advice, the Centre empowers individuals to resolve conflicts amicably and rebuild their relationships.

Objectives of the centre –

- To identify and address underlying issues in relationships, fostering understanding and resolution.
- To equip individuals and couples with practical tools to improve communication, reduce conflict and build stronger bonds.



- To offer expert advice and support to individuals and families navigating various life stages, helping them adjust to changes and challenges.
- To provide information about legal rights and remedies empowering individuals to make informed decisions.
- To provide comprehensive legal guidance and assistance to individuals facing family problems, ensuring access to justice.
- To educate and train future legal professionals, promoting a deeper understanding of family law and its impact on society.
- To provide students with hands-on experience through visits to relevant institutions, such as Family Courts, NGO's, Mahila Bal Kalyan offices etc enhancing their knowledge and skills.

Activities Conducted in the Year 2023-2024

'Sanwardhan Samarabh'

In April 2023 the Family Counselling Centre was recognised by the State Women Commission as a centre to extend counselling services on pro- bono basis to parties involved in family disputes. To celebrate this recognition and expand its reach, the Family counselling centre had arranged a 'Sanwardhan program' (Enrichment Programme). The occasion was graced by the auspicious presence of Hon'ble Rupali Chakankar, Chairperson, Maharashtra State Commission for women. Hon'ble Sonal Patil, Secretary, District Legal Services Authority, Pune was present as a guest of honour. The programme was organised on 11th December 2023 in the 'Dnyaneshwar Hall' of the Shankarrao Chavan Law College.

While delivering the welcome address, Dr. Kranti Deshmukh, Principal of Shankarrao Chavan Law College, explained the object behind establishing the family counselling centre and expressed the gratitude towards Mr. V.V. Shahapurkar Sir for his committed efforts of relieve the suffering of people involved in family disputes.

Hon'ble Rupali Chakankar, Chairperson of Maharashtra State Commission for Women then interacted with students. While addressing the gathering she shared some very disturbing incidents showing the plight of women in Maharashtra. She said vulnerability of women is the result of multiple causes such as illiteracy, patriarchal setup in the society, economic dependency on spouses and unawareness etc. She said that education is the key to address the

The workshop aimed to raise awareness about the legal rights of senior citizens and the significance of drafting a will. Swaroop Godbole, an eminent legal practitioner, delved into the concepts of self-acquired and ancestral property, distinguishing between movable and immovable assets. Godbole explained the registration process for wills and outlined various legal rights available to senior citizens.

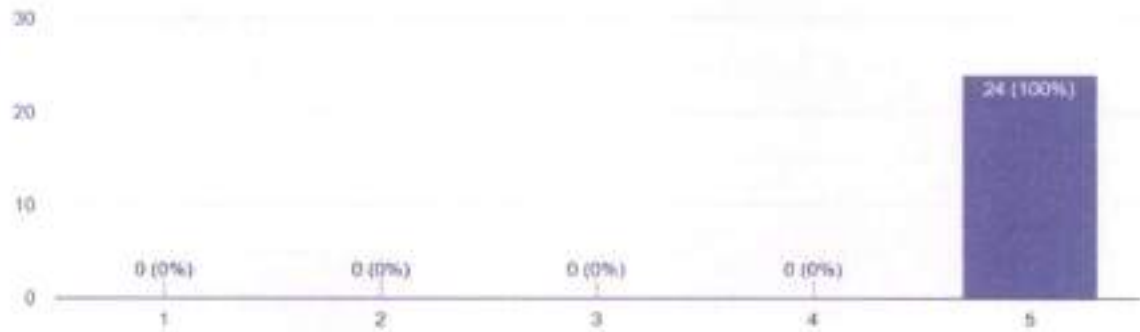

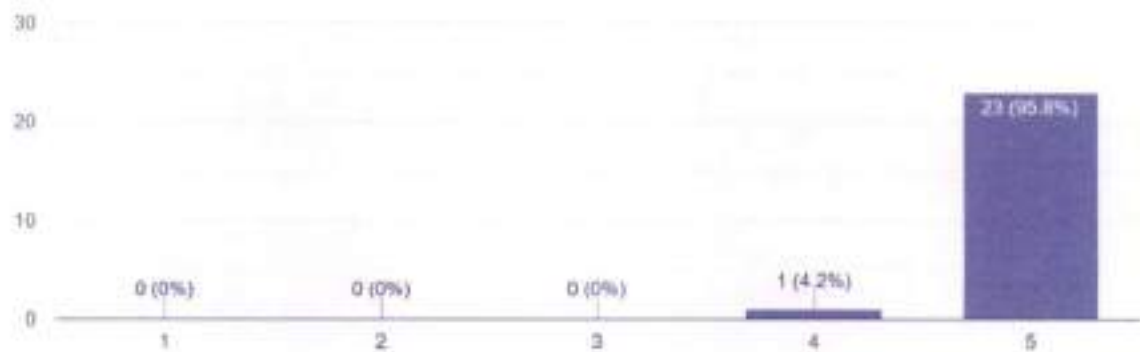

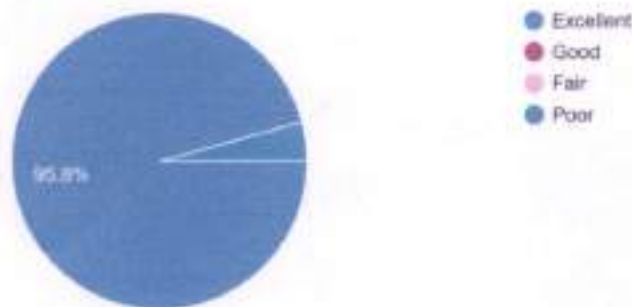

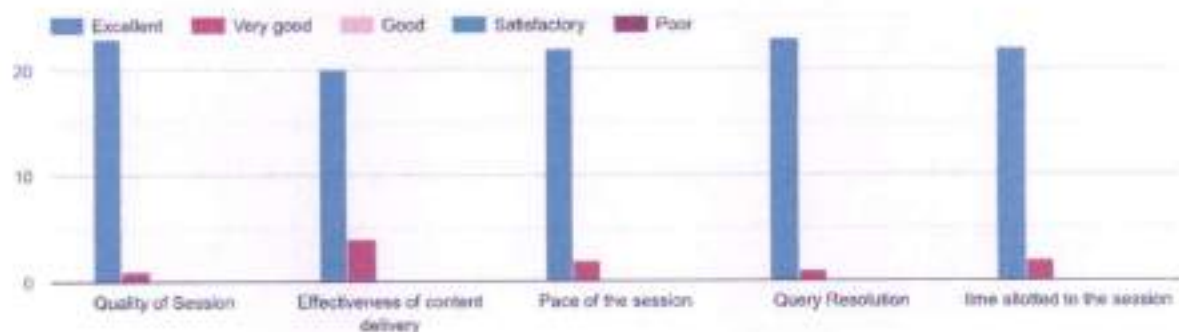
