### Important Instructions to students-

1. Student is expected to maintain 75% attendance per semester. In case of short of attendance disciplinary action will be initiated against student.
2. Students are expected to attend all Guest Lectures arranged by the college. Dress Code for Guest lecture is college Uniform and it is compulsory.

4. In a semester maximum 21 days medical leave will be granted to student after completing formalities.
